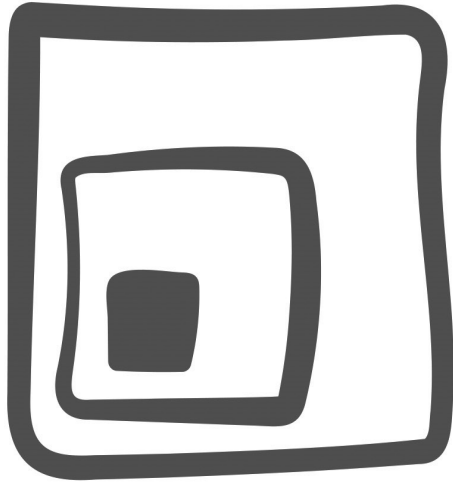

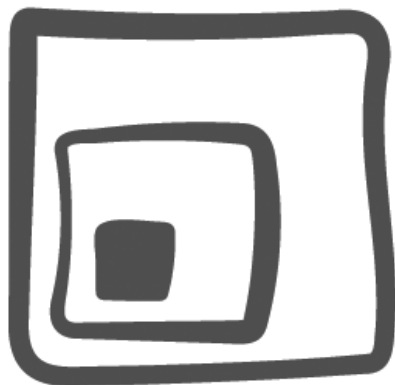

Welcoming address by the President of the Austrian Academy of Sciences

As President of the Austrian Academy of Sciences (OeAW) and Professor Emeritus of Geography, it is my great pleasure to welcome you to the EU-GEO Congress at the OeAW and in Vienna!

For me, geography has always been a very attractive subject. For one, because it provides a broad basic education that includes both natural and social science disciplines. For another, because geography deals with social and environmental policy issues that are extremely important for contemporary society. Personally, I have focused on the topics of urban development, demography, and migration research, and have – or so I aim – been able to provide society and politics with relevant orientation knowledge. This was and is extremely important, especially in such ideologically charged areas as urban development and migration research.

The motto of the congress “Geographies of a Changing Europe” addresses this orientation knowledge in a changing era. Geography is not a monolithic discipline with fixed questions, methods, and content, but rather a dynamic subject that is constantly changing. Therefore, there is no such thing as “the” geography, but rather many geographies, reflecting thematic diversity and a changing world. The only constant here is spatial differentiation and the connection between space and society. Those who ignore this leave geography behind and be-

come part of the neighbouring disciplines of natural and social sciences.

Geography is in good hands at the OeAW. Two institutes have geography as their disciplinary core, namely the Institute for Urban and Regional Research (ISR) and the Institute for Interdisciplinary Mountain Research (IGF). Compared to other OeAW institutes, both institutes are rather small but thoroughly successful. At the centre of the ISR’s research lies the city, in particular the analysis of the structural and social upgrading and downgrading of neighbourhoods, ethnic and social segregation, the changing significance of public space, and the mechanisms of the urban housing market. The IGF focuses on the development of mountain regions in general and the Alps in particular. This involves investigating the effects of climate change on glaciers and gravitational mass movements in the Alpine region, as well as changes in vegetation according to altitude from a global perspective.

Several other institutes are not primarily associated with geography, but make important contributions to regional studies, including in the context of area studies. The Institute of Iranian Studies (IFI) analyses historical, cultural, and political structures in Iran, Afghanistan, and Tajikistan, as well as in societies in the Caucasus, Central Asia, and South Asia that have historical ties to Iran. The Institute for Social Anthropology (ISA) focuses on the programmatic contemporary issues of consensus and conflict in Asia and the eastern Mediterranean, while the Institute for the Cultural and Intellectual History of Asia (IKGA) fo-

cuses on the historical, religious, and cultural structures of East, Southeast, South, and Central Asia.

The EUGEO Congress will take place in the buildings of the OeAW, specifically in the Academy's main building, in the heart of the city. This is a visible sign that science in Austria has arrived and is firmly anchored in the centre of society. And for us, as an elite research institution, this is an important concern: to go out, leave the ivory tower, explain to people what we do, and support politicians in their complex decisions with clear analyses. Anchoring science in society will in the future be supported by the Science Communication Center, a joint project of the OeAW, the University of Vienna, and the Technical University of Vienna, which is supported by two ministries and located in the immediate vicinity of the Academy. A centre for science is being created where science is discussed and communicated. When the EUGEO Congress returns to Vienna in the future, this centre will have been renovated and opened, expanding the possibilities of the congress.

But we're not quite there yet, the EUGEO Congress is taking place now, in 2025. Everything is prepared, the papers have been written, and the congress is ready to begin. I wish all participants inspiring days in Vienna, exciting discussions, and enriching encounters that will strengthen your work and your networks in the long term! Enjoy the city and feel at home at the Academy.

Dear colleagues,

It is a pleasure to welcome you to the 10th EUGEO Congress in Vienna! The EUGEO conferences are established as a thematic open conference format, providing a forum that allows the exchange within the field of geography and spatial oriented research. Following this tradition, we decided to organize this congress under the theme “Geographies of a Changing Europe”. Therewith, we intend to explore the dynamic transformations shaping our continent, its landscapes, and societies; secondly, we engage with conceptual and methodological trends, as well as the perspectives of the discipline itself.

The challenges that shape the continent in our time are considerable and manifold. They comprise transformations towards a sustainable society, demographic changes, and an increasing diversity in many European cities, as well as geopolitical and macroeconomic tensions within Europe and on the global scale. If you look through this conference program, it is apparent that many sessions and presentations address these and further challenges of European societies. In my understanding, this orientation on the challenges of our present-day society is one of the strengths. Therein, we might see a positive change in our discipline: Some decades ago, scholars spent a lot of time and energy discussing the question of what

Organizing a conference with more than 500 participants is not a daily routine, in particular for a small institute like the ISR. An efficient planning process of the conference, as well as the engagement of many colleagues, made this congress work: the organizing committee – Alois Humer, Ursula Reeger, Wiebke Sievers and Barbara Biziak –, which comprises a considerable share of our institute's staff, as well as our conference manager Ioannis Brigkos, facilitated this project. Beyond our institute, the Austrian Academy of Sciences supported this conference from the beginning and provided the necessary infrastructure. Many thanks also go to all colleagues at the ISR and the Event Management team of the Austrian Academy of Sciences for their constant support and commitment throughout the entire process. This is a challenge, as the Academy does not hold the infrastructure of a university, where EUGEO conferences usually are hosted.

At last, the EUGEO utilizes the whole ÖAW Main Building and the Campus

for the four days of the conference. Both buildings have been renovated two years ago. It makes me cheerful to see that the inner courtyard of the campus, which was a grey field for many years, has now become a lively space for scientific exchange and debates, and a place where new, creative ideas emerge. Co-evolution and sustainability of European cities

Over time (decades and even centuries) is observed a rather strong persistency of structural properties (relative size and spacing, functional diversity and complementarity) of the European system of cities. We can explain this long sustainability of European cities through two major aspects of their dynamics that are emphasized in the evolutionary theory of urban systems. The first is the generic adaptive process that is linked to the spatial and hierarchical diffusion of innovations. This is revealed by century's long urban growth patterns and fluctuations that have similarities with the stochastic Gibrat's model, and by the recent evolution in scaling laws of

economic attributes corresponding to the globalization of urban activities. The second process is an historical path dependence that is linked with the configuration of interaction networks between cities and their regional environments. Differentiated models of territorial governance, border effects and geopolitical contexts including temporal barriers and cohesion policies are possible explanatory factors of these historical traces in the urban evolution. These dynamic trends may be considered by stakeholders in local and regional policies for ensuring the viability of such an urban geodiversity in the future.

thoughts from a human geography
perspective***

What might human geography look like if we truly take the planetary seriously – not just as backdrop or scale, but as a fundamental shift in how we understand space, knowledge, and responsibility? In this keynote, I explore how the “planetary turn” challenges us to rethink not only our geographies, but also the ways in which we produce and legitimize knowledge itself. Drawing on the visual and conceptual power of planetary imaginaries – from the iconic “blue marble” to the debris-strewn landscapes of the Anthropocene – I trace how planetary thinking destabilizes inherited binaries such as global/local, nature/culture, and subject/object. This opens the door to a reimagined human

human geography: one that is attuned to entangled temporalities, responsive to deep relationalities, and committed to pluriversal, situated knowledge practices and “tentacular thinking” (Haraway). While the planetary turn itself is far from uncontested – raising critical questions about universality, positionality, scale, and power – it nonetheless offers a provocative lens for rethinking the role of geography today. In light of escalating ecological and epistemic crises, this is less a call for ready-made answers than an invitation to critically reflect on our modes of knowledge and to explore new, perhaps still uncertain, ways of engaging with a shared and fragile planet.

Quantitative approaches for disabled mobility studies: Rationale, issues, pitfalls and results

The aim of this session is to discuss the rationale behind using quantitative or mixed quantitative-qualitative approaches to analyse disabled mobilities, an area which is still in its infancy. 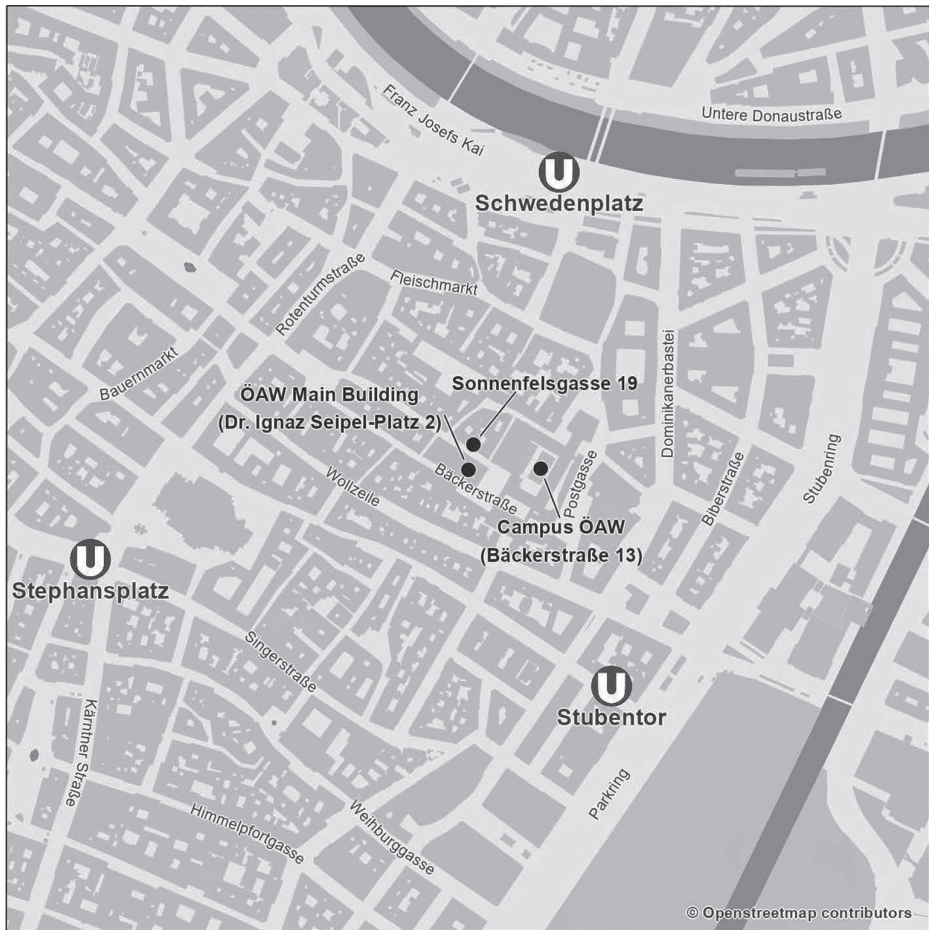

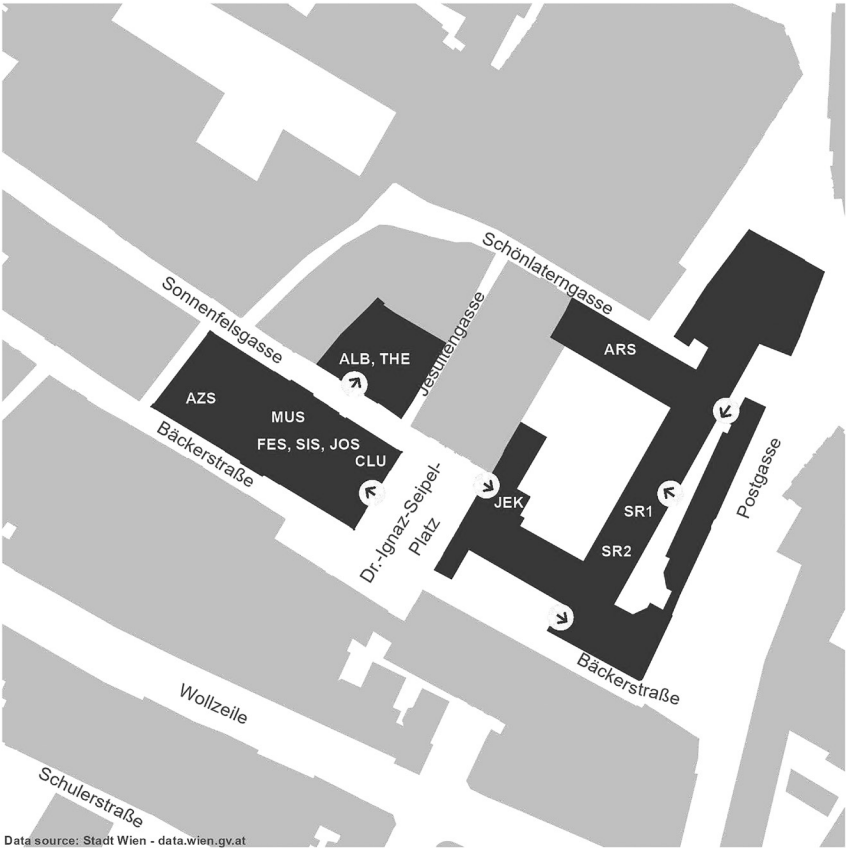

The congress will take place at the Austrian Academy of Sciences right in the historical city centre of Vienna from Monday 8 September to Thursday 11 September 2025.

The campus buildings, designated as historical monuments, are part of the historic Old Vienna University Quarter. Originally constructed in the 17th century alongside the Jesuit Church near Dr. Ignaz Seipel-Platz, the complex was expanded over the centuries to include the Neue Aula, which now serves as the main building of the Austrian Academy of Sciences (ÖAW), as well as a library building. Following extensive renovations, the academy has transformed one of Vienna's most traditional centers of knowledge, bringing it into the 21st century and making it accessible to both the scientific community and the public.

The Academy Campus is situated in the Stubenviertel district, an area closely tied to the academic life of Vienna since the late Middle Ages. Its origins date back to 1385, when Duke Albrecht III established the “Collegium Ducale” across from the Dominican monastery. Architectural archaeology has pinpointed the original buildings for this purpose along today's Postgasse, near the so-called Stöckl building and the towering eastern wing of the later Jesuit College. What began as a few interconnected houses soon expanded into a sprawling, monastery-like complex centered around a Courtyard.

By the early 15th century, the university had added a southern building known as the “Nova Structura” or “Neue Schul,” which served not only the faculty of arts but also lawyers, physicians, and theologians. Student halls of residence, or bursen, including the Silesian Bursa, Sprenger Bursa, and Rosenbursa, quickly sprang up in the surrounding area, solidifying the district's role as a hub of learning.



Conference dinner



On Wednesday 10 September, 19:00 pm., all registered conference dinner participants may join us for an evening at 10er Marie, one of Vienna's most traditional and iconic Heuriger wine taverns. Dating back to 1740, 10er Marie is considered the oldest continuously operated Heuriger in Vienna. With its rustic charm, cosy inner court-yard, and authentic Viennese atmosphere, it offers the perfect setting to unwind, enjoy local wine and hearty Austrian dishes, and experience a beloved part of Viennese culture.

The Heuriger tradition refers to the serving of the current year's wine (heuriger Wein) in taverns typically run by winemaking families. These establishments are known for their relaxed, convivial ambiance and simple regional cuisine—often accompanied by live traditional music.

10er Marie was first officially mentioned in documents in 1740. Originally run by the Ottakring winemaking family Haimböck, the tavern's name is said to derive from both its historic address (Alt-Ottakring No. 10) and the innkeeper's daughter Maria. Among its most notable guests was Crown Prince Rudolf, who was often driven there by his personal coachman, Bratfisch. Later, the tavern also welcomed figures such as the poet Josef Weinheber and the operetta composer Emmerich Kálmán. From the 1940s until 1986, 10er Marie was shaped by its legendary innkeeper Käthe Musil, who transformed it into a meeting place for prominent guests from politics and society.
